Sealed bids for the Rehabilitation of Deicing Storage Facilities, Contract 1 – General and Contract 2 – Electrical, will be received at the office of the Executive Director of the Syracuse International Airport, located at 1000 Col. Eileen Collins Boulevard, Syracuse, New York 13212 until **1:30 pm, local time, on May 24, 2018**, and there, at said office, at said time, publicly opened and read aloud.

The proposed project generally includes the demolition of three existing deicing storage lagoons and existing site features and the construction of two above grade (3.0 MG each) prestressed concrete storage tanks on a deep pile foundation. The project will also include all associated site work, yard piping, stormwater restoration, a new pre-engineered metal building and associated electrical upgrades.

Bidders are advised that this contract will require the contractor and subcontractors to pay prevailing wage rates as a minimum in accordance with the current Federal and State Wage Rate Schedules. Bidders shall be advised that this contract requires participation by certified disadvantaged businesses as follows: **DBE Goal: 6.7%**.

The Contract Documents (consisting of the Advertisement, the Proposal, the Contract Form, and the Specifications) and the Contract Drawings may be obtained only from *WeTransfer*.
