Sealed bids for the Terminal Improvements – Ph IIIC Contract will be received at the office of the Executive Director of the Syracuse International Airport, located at 1000 Col. Eileen Collins Boulevard, Syracuse, New York 13212 until **1:30 pm, local time, on October 23, 2017**, and there, at said office, at said time, publicly opened and read aloud.

The project generally includes the procurement and installation of two electric traction elevators and two sets of escalators.

This project will be conducted under a project Labor Agreement (PLA) and therefore will be bid as a Single Prime Construction Contract (which includes all trades).

Bidders are advised that this contract will require the contractor and subcontractors to pay prevailing wage rates as a minimum in accordance with the current Federal and State Wage Rate Schedules. Bidders are also advised that this contract requires participation by certified disadvantaged businesses as follows: **DBE Goal: 6.7%**.

The Contract Documents (consisting of the Advertisement, the Proposal, the Contract Form, and the Specifications) and the Contract Drawings may be obtained only from *Box.com*.
