Sealed proposals for the construction of Terminal Exit Lane Improvements Contract will be received at the office of the Executive Director of the Syracuse International Airport, located at 1000 Col. Eileen Collins Boulevard, Syracuse, New York 13212 until **1:30 pm, local time, on April 16, 2020**, and there, at said office, at said time, opened and read aloud.

Due to current circumstances, the general public will not be able to attend the bid opening in person. Any interested person or organization who wish to witness the bid opening can do so through a web-based video/teleconference. Details of the bid opening will be made available to all registered plan holders.

This project generally includes complete replacement of the existing exit portal systems at both North and South Concourses with new exit lane breach control systems; includes removal and disposal of existing exit portal systems, installation of temporary passenger egress door, installation and commissioning of new systems at each concourse, modifications to electrical, mechanical, and fire suppression systems.

Bidders are advised that this contract will require the contractor and subcontractors to pay prevailing wage rates as a minimum in accordance with the current State Wage Rate Schedules. Bidders shall be advised that this contract requires participation by certified disadvantaged businesses as follows: **M/WBE Goal: 30%; SDVOB Goal: 6%.**

A non-mandatory pre-bid web-based video/teleconference has been scheduled for **April 1, 2020 at 11:00am** in order to review the specific requirements of this contract. Details on how to participate will be made available to all registered plan holders.

In-person project site reviews shall be conducted, by appointment only, from 12:00pm – 4:00pm on April 1, 2020. Prospective bidders shall contact Mr. Brian Dorman at DormanB@syraairport.org to schedule an appointment during this timeframe and to confirm logistics.
