1. INSTRUCTIONS TO ALL HOLDERS OF CONTRACT DOCUMENTS

The following clarifications, corrections, revisions, additions, and/or deletions included in this Addendum, shall be incorporated into the subject Contract Documents as directed herein with immediate effect.

Bidders must acknowledge receipt of this Addendum (including date) in the proposal documents. Failure of the Bidder to acknowledge this Addendum may result in rejection of the Bid for non-responsiveness.

3. QUESTIONS RECEIVED

The following questions were received via email:

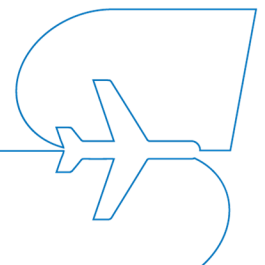
Q1: Who is the original equipment manufacturer (OEM) of the sign panels being replaced in bid item L-125-75?

A1: Refer to the notes on drawings SG-01 through SG-07.

Q2: Who is the manufacturer of signs S-184, S-185, and S-188 for the replacement panels?

A2: Refer to the notes on drawings SG-01 through SG-07.

Q3: In the pre-bid meeting minutes, page 4, under Excavation and Embankment, it lists that unclassified excavation includes stripping of topsoil. Could you please confirm if the quantity is included in bid items P-152-1, Unclassified Excavation, or should the stripping of topsoil be included in bid item T-905-1: Topsoil (Obtained On-Site)?



A3: Stripping of topsoil shall be included in bid item T-905-1, Topsoil (Obtained on-site). Refer to technical specification sections 905-1.1 and 905-4.1, in particular.

Q4: For bid item M-120-3, Lighted Runway Closure Markers, on sheet 18 of the plans it lists that the contractor shall provide (4) new lighted runway closure markers. At the end of the project, will the airport keep the lighted runway closure markers, or will they be returned to the contractor?

A4: The airport will keep the lighted runway closure markers at the end of the project.

Q5: On page 2 of Addendum 1, it lists that all proposal must be receive via email prior to 4:00 PM on 6/13/2024. Should the time be listed as 1:30 PM on 6/13/2024?

A5: Confirming that all submissions must be received by 1:30 on 06/13/2024.

Q6: On page 10 of the Addendum 1, it lists that bids will be opened via Microsoft Teams, at 1 PM on June 14, 2024. In the bid Advertisement and Notice to Contractors, it is listed on June 13, 2024 at 2 PM. Could you please clarify what day and time the bids will be opened via Microsoft Teams?

A6: Bids will be opened via Microsoft Teams on June 14, 2024 at 1PM. The Bid Opening link will be posted on the SRAA Bids page as a part of Addendum #3

Q7: Could an electronic copy of the pre-bid meeting minutes be provided?

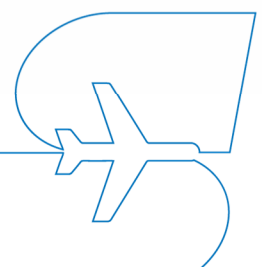

Q8: If some of the DBE forms, for example B-1and B-2, are to not be included at bid time, how many days post-bid would they be due by the apparent low bidder?

A8: The SRAA will work with the apparent low bidder on identifying the best course of action.

Q9: On page 8 of Addendum 1, it lists the DBE goal at 7%. At the pre-bid meeting notes, on page 5, the DBE goal was listed at 7.1%. Could you please clarify what the DBE goal is on this contract?

A9: Confirming that the DBE goal on this project is 7.0%



Q10: Could you please provide the forms that should be submitted as part of the bid? Attached is an example from the previous Taxiway A contact that bid back on August 16, 2023.

Q11: Could the Statement of Surety's Intent form be provided so that we can send it to our bonding agent, and have it returned in time prior to bid submittal?

A11: Forms will be posted as a part of the RFP on the SRAA Bids Page

Q12: Could you please confirm which DBE forms should be submitted at bid time, would it be Forms A-1 & A-2? Please see attached from the website listed in Addendum 1.

Q13: The addendum states that bids must be received by 4:00 PM on page 2 and 1:30 PM on page 5. Can you please clarify what the bid submission deadline is?
